**1.** The Regular License grants you, the purchaser, an ongoing, non-exclusive, worldwide license to make use of the purchased mockup. Read the rest of this license for the details that apply to your use of the mockup, as well as the [FAQs](#) (which form part of this license).

**2.** You are licensed to use the mockup to create one single End Product for yourself or for one client.

**3.** An End Product is one of the following things, both requiring an application of skill and effort.

(a) The End Product is a customised implementation of the Mockup.

(b) The End Product is a work that incorporates the Mockup as well as other things, so that it is larger in scope and different in nature than the Mockup.

## Things you can do with Sports Templates Mockups

**4.** You can create one End Product for a client, and you can transfer that single End Product to your client for any fee. This license is then transferred to your client.

**5.** You can modify or manipulate the Mockup. You can combine the Mockup with other works and make a derivative work from it. The resulting works are subject to the terms of this license. You can do these things as long as the End Product you then create is one that's permitted under clause 3.

## Things you can't do with Sports Templates Mockups

**6.** You can't Sell the End Product, except to one client.

**7.** You can't redistribute, lease, license, sub-license or offer our files to and third-party.

**8.** You can't redistribute the Mockup as stock, in a tool or template, or with source files. You can't do this with a Mockup either on its own or bundled with other items, and even if you modify the Mockup. You can't re-distribute or make available the Mockup as-is or with superficial modifications. These things are not allowed even if the re-distribution is for Free.

**9.** You can't use the Mockup in any application allowing an end user to customise a digital or physical product to their specific needs, such as an "on demand", "made to order" or "build it yourself" application.

**10.** Although you can modify the Mockup and therefore delete unwanted components before creating your single End Product, you can't extract and use a single component of a Mockup on a stand-alone basis.

For example: You purchased a mockup containing a full sports uniform. You can delete unwanted parts from the mockup. But you can't extract a part to use outside of the mockup.

**11.** You must not permit an end user of the End Product to extract the Mockup and use it separately from the End Product.

## Other license terms

**12.** You can only use the Mockup for lawful purposes.

**13.** Mockups that contain digital versions of real products, trademarks or other intellectual property owned by others have not been property released. These Mockups are licensed on the basis of editorial use only. It is your responsibility to consider whether your use of these Mockups requires a clearance and if so, to obtain that clearance from the intellectual property rights owner.

**14.** This license applies in conjunction with the [Sports Templates Terms and Conditions](#) for your use of Sports Templates.
